Heidi's original conversation roadmap:

Ideas for story / proof / angles etc:

Child labor, modern slavery and money laundering: use the paper and money trail to directly connect the money generated by the small hands of 12 year olds ending up buying private planes and tequila and first-class hotels in the bahamas for KS. We want to prove that money from US is going into illegal channels and used it to get the money offshore and that was straight from david columns. lists calculated from each member, a couple is worth this much, a 14 year old child is worth this much: they're not looking at how to serve god or evangelize they're calculating how much each person is worth, and if they want to keep their european model moving they're calculating the value of the US members. BCC has introduced a new currency (david columns) and how they look at people as numbers and calculate how much they are worth for working in shopping malls and raves in the middle of the night like the story of the girl in Detroit.

We have the DOJ in netherlands, norway and US ready to start an investigation. an official criminal filing is still pending. 70-80% of it is prepared and ready to go and they have access to DOJ in netherlands and norway already and can go to US in cooperation in terms of getting KS testifying in court.

final decision of the court by april 18. only switzerland and cyprus and canada. if DOJ files against leaders of the church instead of jonathan's defense instead of offense by the government / court.

we need to file a criminal case against the church. informing the US media and tell the whole story.

I think the psychological angle for audiences is 'cult expose' and psychopathic bullies in positions of power getting caught trying to come to America.

- show how they don't care and consider themselves higher than the law: look at money laundering systems and how they talk to the courts and governments: "find KS yourself etc." and lower downs like Tombre they just followed blindly what BAL instructed them and they are exposed and BAL is running away from justice, they just leave their own people to get penalties and imprisonment.
- the message of the story is that there is a cult destroying people who are unable to think or act for themselves anymore because they are told to kill their own feelings and their own will. you are not even capable to act normal people look at you like you're an alien if you try to go outside. every religion has a right to exist but if you do it with a purpose to use and abuse weak souls under the name of god that is evil.
